

REQUEST FOR PROPOSAL (RFP)

Procurement of Datacenter Firewall System (Firewall Cluster) for LankaPay Private Limited.

1. LankaPay (Private) Limited (LPPL) is a limited liability company incorporated in Sri Lanka in 2002 and jointly owned by the Central Bank of Sri Lanka (CBSL) and the Licensed Commercial Banks in Sri Lanka. LankaPay is expecting to follow the competitive bidding process for Supply, Delivery, Implementation, Configuration, and Maintenance of Datacenter Firewall System (Firewall Cluster for Datacenter Head Office and Standalone Firewall for DR Site) for LankaPay Private Limited.
2. Request for Proposal (RFP) follows the General Procurement Notice (GPN) for obtaining the initial technical and financial proposal under the RFP No. LPPL/CB/2025-26/077 (B). This advertisement of invitation for bids is not part of the bidding document. Bidders to whom the bidding document is issued are only entitled to submit the proposal. The Evaluation Committees consisting of industry experts reserves the right to accept or reject any proposals without adducing any reason at any time prior to selection.
3. Bidding will be conducted using the National Competitive Bidding procedures specified in the LankaPay Procurement Guidelines and is open to all Bidders from eligible source country that meet the following minimum qualification criteria.
 - a. The Bidder should be a company registered and operating in Sri Lanka.
 - b. The bidder should have valid authorization to sell, implement, and provide support services for the proposed solution in Sri Lanka.
 - c. The bidder must have successfully completed at least three (03) implementations of the proposed solution within the last two (02) years in Sri Lanka.
 - d. The bidder must employ a minimum of two (02) engineers with certifications and qualifications relevant to the proposed or similar solution implementation, each possessing at least five (05) years of experience in similar implementations.
 - e. The bidder must demonstrate financial stability and satisfactory performance during the last three (03) year periods.
